Reserve Fund: Helen made a motion to write a letter to the Town requesting the information on the reserve fund from 2009 to 2016, what the balances and expenses were. Jill seconded. Motion passed. Minimum Wage Issue: Russ made a motion to use Reserve Funds if needed if the library goes over budget. Jill seconded. Motion passed.
